

## **Course Fees for Students NOT Paid or Reimbursed by an Organisation [10383NAT]**

### **For students whose fees are paid by or reimbursed by an organisation**

- AUD **\$9,500** for online payments
- The course fee covers all four modules course materials, case studies, tutorials, hands-on demonstrations, live-streamed workshops and access to personal online tutorials available online at [www.cepia.com.au](http://www.cepia.com.au).

### **For students whose fees are paid via Edstart**

- AUD **\$9,500** via Edstart (not including any interest you may incur through your Edstart plan)
- Prior to signing up for the course, apply to Edstart and choose your payment plan
- Once approved, registered for your CEPIA course
- Request an invoice at enrolment and submit this to Edstart

### **For students who pay their own fees (without reimbursement from an organisation)**

The Standards for NVR Registered Training Organisations, 2012, (SNR11.3) require CEPIA to comply with 11.3 (C) (Option 3) in order to protect student fees paid in advance.

“The RTO may accept payment of no more than \$1,500 from each individual student prior to the commencement of the course. Following course commencement, the RTO may require the payment of additional fees paid in advance from the student but only such that at any given time, the total amount required to be paid which is attributable to tuition and other services yet to be delivered to the student, does not exceed \$1,500.”

Such students will be required to pay:

- AUD **\$1,500** at registration
- Six further monthly instalments of AUD **\$1,500**

**Total for all 4 Modules = AUD \$10,500.**

Students are required to complete the form below and submit to CEPIA for manual processing. There is no online payment option for self-paying students, it is via invoice only.

Fees will be automatically debited to their nominated credit card at the intervals stated.
